Moreover, re-accreditation is also recommended for Intake Batch 2019 under Level-II subject to submission of satisfactory compliance report along-with evidences on all observations/ weaknesses & concerns mentioned in detailed visit report.  The Institution, however, is required to address all observations/ weaknesses & concerns, particularly in Criteria 2 & 3 as mentioned in the visit report as part of its CQI process before applying for re-accreditation visit under OBA.
B.E. Electrical (Re-Accreditation)	Based on the satisfactory level of compliance against accreditation criteria/ quality standards and implementation of the Outcome Based Assessment procedures & CQI, re-accreditation is granted for one (01) year i.e. Intake Batch 2018 under Level-II.  Moreover, re-accreditation is also recommended for Intake Batch 2019 under Level-II subject to submission of satisfactory compliance report along-with evidences on all observations/ weaknesses & concerns as mentioned in detailed visit report.  The Institution, however, is required to address all observations/ weaknesses & concerns, particularly in Criteria 3 as mentioned in the visit report as part of its CQI process before applying for re-accreditation visit under OBA.
